TO: ALL PROSPECTIVE BIDDERS:

The following changes, additions, clarifications, and/or deletions amend the above-captioned Invitation to Bid, and shall become an integral part of the Bids submitted, and the Contracts to be executed for **BRICKELL AVENUE ROADWAY IMPROVEMENTS FROM SE 8TH STREET TO SE 15TH ROAD - D2 – INVITATION TO BID (“ITB”) No.: 18-19-038** (the “Project”). Please note the contents herein and affix same to the documents you have on hand.

All attachments (if any) are available on the Office of Capital Improvement's (OCI) website and are part of this Addendum.

A. The following are revisions to the ITB document:

1. The highlighted note on page 5 of the Contract Document is hereby deleted in its entirety, and replaced by the following:

Please Note: Work shall be performed Monday through Thursday from 9:00 p.m. to 12:00 a.m. (midnight) for hydro-plasting and other higher noise level work and from 12:00 a.m. (midnight) to 5:00 a.m. for lesser noise items such as pavement markings. Any Work to be performed outside of these times must be requested in writing to the Project Manager forty-eight (48) hours prior to the requested change.

2. Section 3 – ITB Supplemental Terms and Conditions, Article 1. Contract Time and Hours is hereby deleted in its entirety, and replaced by the following:

1. Contract Time and Hours

The Contractor shall furnish all labor, materials, equipment, tools, services, and incidentals to complete all Work at a rate of progress that will ensure completion of the Work within the Contract Time.

Contractor shall have one hundred twenty (120) calendar days from the date of the Notice to Proceed to achieve Substantial Completion of the Contract. Contractor shall have an additional forty-five (45) calendar days to achieve Final Completion of the Contract.

The Contractor shall maintain strict adherence to the mandated Contract time and schedule due to the time sensitive nature of the Project's funding sources unless otherwise indicated by the City in writing


THIS PROJECT REQUIRES **NIGHT-TIME** CONSTRUCTION ONLY. Work shall be performed Monday through Thursday from 9:00 p.m. to 12:00 a.m. (midnight) for higher noise level work (hydro-blasting) and 12:00 a.m. (midnight) to 5:00 a.m. for lesser noise items (i.e. pavement markings). Any Work to be performed outside of these times must be requested in writing to the Project Manager 48 hours prior to the requested change. The Project Manager will notify the Contractor in writing of any changes in approved Work hours.

B. The following are the inquiries received and the corresponding responses:

Q1. There is a contract requirement that Contractors have a minimum of Five (5) years of experience under its current business name. Can the experience of the Contractor's personnel be used to meet this requirement?

A1: No. The minimum requirements must be met by the Bidder, and not by staff members.
