BRICKELL AVENUE ROADWAY IMPROVEMENTS FROM SE 8[™] STREET TO SE 15[™] ROAD - D2 B-30874

Scope of Work: The work consists of furnishing all materials, labor, and equipment necessary for **nighttime construction of roadway improvements** such as sidewalk restoration, construction of new decorative crosswalks at intersections, miscellaneous curb, & gutter restoration and repair of impacted driveway approaches, as needed. <u>All construction equipment and material staging must be cleared from view by 6:00 am each morning</u>.

Minimum Requirements: Prospective Bidders shall, as of the Bid Due Date:

- **A.** Have a current **Certified General Contractor ("CGC")** license from the State of Florida <u>and</u> have a minimum of five (5) years' experience **under its current business name**.
- **B.** Have experience as the Prime Contractor for at least three (3) completed projects of similar scope and complexity (e.g., construction of similar roadway improvement projects), within the last five (5) years. Bidders must have a proven record of successfully completing projects consisting of the construction of roadway/horizontal projects involving public right-of-way, construction/repair of sidewalks and curb & gutter restoration and maintenance of vehicular traffic.

Reference projects must be submitted utilizing **Form ITB-PCR (page 89)** and must attest that the Bidder i) was the Prime Contractor for the project; <u>and</u> ii) self-performed at least thirty percent (30%) of the physical labor construction work for the project. If the Work is phased, the self-performance percentage requirement will apply to each phase or segment of the Work – severally.

The City reserves the right to request additional / supplemental information and/or contact listed persons pertaining to Bidder's experience / minimum requirements.

Please Note: Work shall be performed Monday through Friday from 9:00 p.m. to 12:00 a.m. (midnight) for hydro-plasting and other higher noise level work and from 12:00 a.m. (midnight) to 5:00 a.m. for lesser noise items such as pavement markings. Any Work to be performed outside of these times must be requested in writing to the Project Manager forty-eight (48) hours prior to the requested change.

The Department of Procurement ("Procurement") has scheduled a Voluntary Pre-Bid Conference to be held on the following date, time, and location:

All bids shall be submitted in accordance with the Instructions to Bidders identified in Section 1, Instructions for Submission. Bidders must be submit: one (1) original bid package; and one (1) electronic bid package on a CD or USB Drive in SEARCHABLE PDF format, at the time, date, and location indicated where bids will be publicly opened. Failure to submit one (1) original full set may result in the bid being deemed non-responsive. Any bids received after the time and date specified will be rejected and will not be considered. The responsibility for submitting a bid before the indicated time and date is solely and strictly that of the Bidder. The City is not responsible for any delay regardless of the cause. Bidder assumes all risk for any delay or mistake.

BIDDERS ARE ADVISED THAT BIDS SUBMITTED WITH IRREGULARITIES, DEFICIENCIES, AND/OR TECHNICALITIES THAT DEVIATE FROM THE MINIMUM QUALIFICATIONS, EXPERIENCE, AND SUBMISSION REQUIREMENTS OF A REQUEST FOR QUALIFICATIONS (RFQ), REQUEST FOR PROPOSALS (RFP), INVITATION TO BID (ITB), INVITATION FOR BIDS (IFB), INVITATION TO QUOTE (ITQ), REQUESTS FOR LETTERS OF INTEREST (RFLI), AND REQUEST FOR SPONSORSHIPS (RFS) SHALL RESULT IN A NON-RESPONSIVE DETERMINATION. ANY SOLICITATION ISSUED AFTER MAY 6, 2019 SHALL COMPLY WITH APM 2-19. APM 2-19 IS EXPRESSLY INCORPORATED BY REFERENCE AND MADE A PART OF THIS AGREEMENT AS IF SET FORTH IN FULL. ONLY MINOR IRREGULARITIES, DEFICIENCIES, AND TECHNICALITIES MAY BE ALLOWED TO BE TIMELY CURED BY BIDDERS AT THE SOLE DISCRETION OF THE CITY. MATERIAL IRREGULARITIES, DEFICIENCIES, AND TECHNICALITIES CANNOT BE CURED BY THE BIDDER, AND ARE NOT WAIVABLE BY THE CITY.
