**Scope of Work:** The Work consists of furnishing all materials, labor and equipment necessary for the construction of one (1) single-family, infill home on a residential lot owned by the City of Miami ("City") and located at 1544 N.W. 58<sup>th</sup> Terrace.

The Selected Bidder shall, consistent with applicable state and local licensing laws and ordinances, provide through qualified and properly licensed contractors and/or subcontractors, complete construction of the infill home in accordance with the provided architectural/construction drawings and specifications.

- **B.** Complete and submit two (2) reference forms for Projects that must demonstrate that the Bidder: i) served as the Prime Contractor for the referenced Project provided; <u>and</u> ii) self-performed at least thirty percent (30%) of the physical labor construction work for the referenced Projects. (Please complete two (2) Reference Letters to certify Bidder's experience. Located on Page 100). If the Work was phased, the self-performance percentage requirement will apply to each phase or segment of the Work severally.

The Selected Bidder, hereafter referred to as Contractor, shall self-perform at least thirty percent (30%) of the physical construction labor work for the **Single-Family Infill Home at 1544 NW 58<sup>th</sup> Terrace** project ("Project") The City of Miami (the City) reserves its right to require documentary confirmation of this requirement.
