



AFFIDAVIT for 30-day Temporary or Permanent Electric Service

To Be Executed by the Owner and/or Tenant, Building Contractor & Electrical Contractor

It is understood that the temporary or permanent electrical approval by the Electrical Section given in connection with the building being constructed under Building Permit No. _____ and Electrical Permit No. _____ at _____ for the construction of _____ is being given only for construction purposes or testing the following installations being made in said structure: _____

Section 112 of the Florida Building Code authorizes the Building Official to approve the use of electrical current for irrigation, security, humidity control, emergency power and lighting, for testing or construction purposes, provided that the Electrical Contractor maintains the installation in such manner that there is no hazard to life and property.

Such approval is in no event to be considered a release of said structure for purposes of use or occupancy, and no occupancy shall be granted or permitted until final inspections have been called for and approved by the inspection divisions concerned, and an occupancy permit obtained.

The undersigned individuals also understand that the temporary or permanent electrical approval may be rescinded, and the electric power may be disconnected at the discretion of the Building Department if the building concerned is occupied before the final inspections are approved and a Certificate (or Temporary Certificate) of Occupancy is issued.

I, _____, being first duly sworn, depose and say that I am the Owner of the above described property, and that I agree that the structure covered in this agreement shall not be occupied until the building contractor has obtained the approval of all final inspections.
