### NOTICE TO CONTRACTORS

Sealed bids will be received by the **City of Miami, Office of the City Clerk, City Hall, 1<sup>st</sup> Floor, 3500 Pan American Drive, Miami, Florida 33133-5504** for:

**CURTIS PARK BOAT RAMP, B-35806**

**Bids Due: THURSDAY, JANUARY 21, 2015 @ 3:00 P.M.**

**Scope of Work:** The Work consists of furnishing all materials, labor, and equipment necessary for improving the function of the in-water and upland components of the boat ramp facility. The improvements include site demolition, constructing a pier, dock and site drainage; repairing the existing dock and ramp; modifying the existing parking lot to increase the boat trailer and standard parking spaces; and remediating contaminated soils.

The boat ramp shall remain closed for the duration of the construction and renovation activities. The Contractor shall properly protect the abutting pool facility from all construction activities and debris. Demolition and/or reconstruction of the abutting pool facility may occur during construction of the Project. The full scope of work is detailed in the construction plans for the Project.

**Minimum Requirements:** Prospective Bidders must have **i)** a current certified General Contractor or Building Contractor license issued by the State of Florida; **and**, in addition, must have a minimum of ten (10) years of experience, under its current business name in marine and foundation construction supported by references for at least three (3) boat ramp or dock projects completed within the past seven (7) years. At least one of these referenced projects must have been performed within the State of Florida.

Prospective Bidders shall also provide proof of completing forty (40) hours of WAZHOPER training or refresher training in the past twelve (12) months.

The selected Bidder, hereinafter referred to as Contractor, must self-perform at least thirty percent (30%) of the physical construction work for the Project.
