MANATEE BEND SHORELINE IMPROVEMENTS – D2

Bids Due: TUESDAY, NOVEMBER 24, 2015 @ 2:00 P.M.

Scope of Work: The Work consists of furnishing all materials, labor, and equipment necessary for the replacement of approximately 240-feet of seawall by installing 159-feet of new seawall landward of the existing seawall and removing 93.5-feet of existing failed seawall. The scope of work also includes the installation of an 8-foot by 30 foot (240 sq. ft.) kayak launch at a 10:1 slope. In addition, the project scope requires the placement of 90 cubic yard of riprap landward of the existing seawall.

Minimum Requirements: Prospective Bidders must have **i)** a current certified General Contractor license issued by the State of Florida **or** a Miami-Dade County Certificate of Competency as a General Engineering Contractor; **and**, in addition, must have a minimum of five (5) years of experience, under its current business name, in heavy marine and foundation construction supported by references for five (5) projects within the past seven (7) years. At least one of these projects must have been performed within the State of Florida. Steel sheet piling installation experience shall include construction of similar waterfront bulkheads in historically and environmentally sensitive environments. Cast-in-place marine construction experience is required. The Contractor's Project Manager that will be assigned to this Project must have at least five (5) years of construction experience in heavy marine construction supported by three (3) reference letters completed by the project owners to substantiate the Project Manager's experience.

The Contractor's Superintendent that will be assigned to this project must have at least five (5) years of construction experience in heavy marine construction supported by three (3) reference letters completed by the project owners to substantiate the Superintendent's experience.

The selected Bidder, hereinafter referred to as Contractor, must self-perform at least twenty percent (20%) of the physical construction work for the Project.
