Request for Information

- Q1. What is the proposed construction budget for the project?
- A1. The Project does not have an established construction budget at this time.
- **Q2**. Must the primary Project Manager for this job be a licensed engineer? If so, may the engineer be employed by a sub-consultant to the Prime versus a direct employee of the Prime?
- **A2**. Yes, the Project Manager shall be a professional engineer registered and licensed in the State of Florida. Yes, the Project Manager/Engineer may be employed by a subconsultant to the Proposer.
- Q3. Section 4.0(a)(7) states that the Proposer shall complete and submit Form RFQ-PP for this section of its Response. Provide a comprehensive summary of the Proposer's summary of the Proposer's CEI experience.
- A3. This Section has be <u>revised</u> as follows with the deletion of CEI and the inclusion of the underlined words: Proposer shall complete and submit Form RFQ-PP for this section of its Response. Provide a comprehensive summary of the Proposer's <u>architectural and engineering</u> experience.
- **Q4**. Will a Community Small Business Enterprise (CSBE) firm be applicable in meeting the Community Business Enterprise (CBE) requirement for the minimum 15% participation?
- A4. No. The awarded firm will be required to subcontract a minimum 15% of the contract value to a Certified Business Enterprise (CBE) firm.

- Q5. The RFQ indicates that the Florida Department of Transportation (FDOT) Notice of Qualifications document will only be required when executing an agreement with the successful Proposer. As it is not listed on p. 19 under "Response Submission Format Section E", can we assume that it is not required for inclusion in the submission package at this time?
- **A5**. No, please include the FDOT Notice of Qualifications document in Section 4(e) as indicated on Page 18 of the RFQ.
