THE CITY OF MIAMI WILL ISSUE THREE REQUESTS FOR PROPOSALS (RFPs) FOR FUNDING FROM THE FEDERAL: (1) HOME INVESTMENT PARTNERSHIPS PROGRAM (HOME); (2) COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) AND EMERGENCY SOLUTIONS GRANT (ESG) PROGRAMS; (3) AND, HOUSING OPPORTUNITIES FOR PERSONS WITH AIDS (HOPWA) PROGRAM FOR FISCAL YEAR 2017-2018 (October 1, 2017 thru September 30, 2018).
