2. Discussion and proposed resolution authorizing the City Manager to grant Citrus Health Network, Inc. an extension of the time for the 2013-2014 agreement for Emergency Solutions Grant ("ESG") program from April 1, 2014 to September 30, 2015.
3. Discussion and proposed resolution authorizing the City Manager to approve the City of Miami's ("CITY") five (5) year Public Housing Agency ("PHA") plan for fiscal year 2015-2019, and the Administrative Plan in connection with the implementation and administration of the City's Section 8 Housing Choice Voucher and Moderate Rehabilitation Programs.
