Federal regulations governing CDBG and other HUD programs require that a participating jurisdiction provide citizens with reasonable notice of and an opportunity to comment on the priorities set forth on the annual Action Plan or any amendments thereafter.

1. Discuss and propose resolution authorizing the approval of the amendment of the Annual Action plan for fiscal year 2016-2017 previously approved by Resolution No.16-0132 adopted on March 24, 2016 and the approval of the City of Miami's ("City") Annual Action plan for fiscal year 2017-2018; authorizing the City Manager to amend the Annual Action plan for fiscal year 2016-2017 and submit the Annual Action plan for fiscal year 2017-2018 to the United States Department of Housing and Urban Development ("HUD") for review and approval.

*As per the Code of Federal Regulations 24 CFR 91.200, the U.S. Department of Housing and Urban Development (HUD) requires entitlement communities that receive funds under its grant programs to prepare an annual Action Plan, which details proposed activities to maximize the benefits of federal funding for low income residents. The City of Miami is required to report annually to HUD on projects funded through the Community Development Block Grant (CDBG); Home Investment Partnership (HOME); Emergency Solutions Grant (ESG), and Housing Opportunities for People with AIDS (HOPWA) programs.*

*The City of Miami Community & Economic Development Department (DCED) has completed drafts of its FY2017-2018 annual Action Plan and of its FY2016-2017 amendments to the annual Action Plan. Both plans will be available for review and comment for a period of no less than 30 days. The review and comment period begins on **Tuesday, June 13, 2017** and ends on **Wednesday, July 12, 2017**. The DCED will present both plans to City Commission for approval on **Thursday, July 13, 2017 at 9:00 a.m.** (Public Hearing) at City Commission Chambers, 3500 Pan American Drive, Miami, FL 33133, to provide the public an opportunity to comment on both plans.
