## Downtown Miami Bicycle and Pedestrian Mobility Improvements Bids Due: March 20, 2017 @ 2:00 P.M.

**Scope of Work:** The Work consists of furnishing all materials, labor, and equipment necessary for the installation of bicycle and pedestrian improvements such as bicycle lanes, shared use lane markings, pedestrian signalization improvements, crosswalks and ADA ramps throughout the Omni, Downtown and Brickell Areas.

Minimum Requirements: Prospective Bidders shall, as of the Bid Due Date:

- 1. have been prequalified by the Florida Department of Transportation (FDOT) as a general contractor authorized to complete FDOT projects;
- 2. have a current certified General Contractor license from the State of Florida; and
- 3. must also have a minimum of five (5) years of experience under its current business name in the construction of roadway/horizontal projects involving public right-of-way, public utilities and maintenance of traffic, supported by references for five (5) projects completed within the past ten (10) years.

Submitted reference projects must demonstrate that the Bidder: i) was the Prime Contractor for the project; and ii) self-performed at least thirty percent (30%) of the physical construction work for the project. The selected Bidder, hereinafter referred to as "Contractor", must self-perform at least thirty percent (30%) of the physical construction work for the Downtown Miami Bicycle and Pedestrian Mobility Improvements project (the "Project").

The provisions of <u>FHWA-1273</u> and LAP Divisions 1 Specifications (On-System) are hereby attached and made part of the Contract documents. All work associated with this Project must adhere to the terms and requirement of this Contract. submitted in accordance with the Instructions to Bidders. Bids must be submitted in duplicate originals and on CD or USB Drive in PDF format at the time, date and place above, where bids will be publicly opened. Any bids received after the time and date specified will not be considered.
