Based on the background below, the Department of Procurement ("Procurement") hereby requests authorization to: 1) reject the sole Bid received for Brickell Avenue from SE 8th Street to SE 15th Road Roadway Improvements - D2 - ITB No.: 16-17-042 – Project No.: B-30874; and 2) re-issue the ITB for Brickell Avenue from SE 8th Street to SE 15th Road Roadway Improvements - D2 - Project No.: B-30874.

Background

On September 27, 2017, Procurement received one (1) Bid in response to the solicitation for ITB No.: 16-17-042 - Brickell Avenue from SE 8th Street to SE 15th Road Roadway Improvements - D2 - Project No.: B-30874 (the "Project") from JVA Engineering Contractor, Inc. ("JVA") (see attached Bid Security List). JVA's bid was reviewed and deemed responsive; however, the Bid exceeds the Office of Capital Improvements' ("OCI") budget for the Project by approximately \$94,000.00. In addition, OCI has decided to re-evaluate the Project's scope and specifications to determine whether any alterations are required in order to bring the Bids in compliance with the budget for the Project.

Accordingly, pursuant to Section 18-91 of the City Code, as amended, Procurement hereby requests your approval below authorizing: 1) rejection of the sole Bid received from JVA; and 2) re-issuance of the Invitation to Bid for Brickell Avenue from SE 8th Street to SE 15th Road Roadway Improvements - D2 - ITB No.: 16-17-042 - Project No.: B-30874, pending completion of OCI's re-evaluation of the Project's scope and specifications.
