Sealed Bids will be received by the **City of Miami, Office of the City Clerk, City Hall, 1st Floor, 3500 Pan American Drive, Miami, Florida 33133-5504** for:

BRICKELL AVENUE FROM SE 8TH STREET TO SE 15TH ROAD ROADWAY IMPROVEMENTS - D2

Bid Due Date: September 20, 2017 @ 2:00 P.M. (Local Time)

Scope of Work: The work consists of furnishing all materials, labor, and equipment necessary for **night-time construction of roadway improvements** such as sidewalk restoration, construction of new decorative crosswalks at intersections, miscellaneous curb & gutter restoration and repair of impacted driveway approaches, as needed. **All construction equipment and material staging must be cleared from view by 6:00 am each morning.**

Minimum Requirements as of Bid Due Date:

- A.** Bidders must have: **i)** a current certified General Contractor license issued by the State of Florida **or ii)** a Miami-Dade County Certificate of Competency as a General Engineering Contractor; **and**, in addition, must have a minimum of five (5) years of experience, under its current business name in the construction of roadway/horizontal projects involving public right-of-way, construction/repair of sidewalks and curb & gutter restoration and maintenance of vehicular traffic, supported by references for five (5) projects completed within the past ten (10) years.
- B.** The five (5) submitted reference projects must demonstrate that the Bidder: **i)** was the Prime Contractor for the referenced project provided; **and ii)** self-performed at least thirty percent (30%) of the physical construction labor work for the referenced project. **Bidders shall use the reference project form letter provided herein on page 97.**

The Selected Bidder, hereafter referred to as the Contractor, shall self-perform at least thirty percent (30%) of the physical construction labor work for the negotiated construction cost of the entire Project utilizing its own employees. The City of Miami (the City) reserves its right to require documentary confirmation of this requirement.

Please Note: **Work shall be performed Monday through Friday from 9:00 p.m. to 12:00 a.m. (midnight) for hydro-plasting and other higher noise level work and from 12:00 a.m. (midnight) to 5:00 a.m. for lesser noise items such as pavement markings. Any Work to be performed outside of these times must be requested in writing to the Project Manager forty-eight (48) hours prior to the requested change.**

The City is not responsible for any delay no matter what the cause.
