**Scope of Work:** The Work consists of furnishing all materials, labor, and equipment necessary for the construction of a new, multi-use turf field to include lines for one (1) regulation sized soccer field, one (1) regulation sized football field, and two (2) regulation U-12 soccer fields. The park shall also include a new exercise station with a shade canopy, two (2) small bleachers, a new pre-fab building for storing sports equipment, the reworking of the existing irrigation system, the reconfiguration of the existing sports lighting system to provide illumination of all fields, and the re-routing of the concrete walkways around the new fields.

The full Scope of Work is detailed in the construction drawings.

- C. Installer certification by the turf manufacturer referenced herein shall be submitted with Bid.

The Selected Bidder, hereafter referred to as Contractor, shall self-perform at least thirty percent (30%) of the physical labor construction work for the negotiated construction cost of the entire Project utilizing its own employees. The City of Miami (the City) reserves its right to require documentary confirmation of this requirement.
