Meet the City of Miami Civil Service Board

The Civil Service System is merit-based and designed to ensure that employees are hired, retained, and promoted on the basis of what they know and not who they know. In accordance with Section 36 of the City Charter, the Civil Service Board endeavors to ensure that employees in the classified service are hired, promoted, and retained based upon merit, efficiency, character and industry and not political patronage.

Therefore, the City Charter provides for a five-Member Civil Service Board responsible for adopting, amending, and enforcing a code of rules and regulations providing for appointment and employment in all positions in the classified service, subject to approval by the City Commission. Three of the members are appointed by the City of Miami Commission, and two are elected by employees with civil service status.
