

# CIVIL SERVICE BOARD ELECTIONS/ APPOINTMENTS

The City's Civil Service Board consists of five (5) members - three (3) of whom are appointed by the City Commission as a whole, and two (2) of whom are elected by employees.

On **Thursday**, **March 31**, **2016** and **Friday**, **April 1**, **2016** an election will be held for the two elected members. Service on the Board will be for a two-year term that will commence after the results of the election are confirmed by the City Commission. Present members' terms are due to expire May 8, 2016.

For the two elected seats, eligible voters in the Civil Service Board election shall be full-time City of Miami employees **who currently have or formerly held probationary or permanent Civil Service status**. Temporary employees (full or part-time) are not eligible to vote. Absentee or proxy voting is not permitted.

Interested candidates for the Board should refer to Administrative Policy APM-1-79 for specific rules. Qualified candidates will be required to file for either Group No. 1 or No. 2; as well as file the following forms with the City Clerk's Office:

- (a) A Petition Form signed by at least 10 City employees with Civil Service status;
- (b) An Acceptance Form, duly signed by the candidate.

The Petition Form and the Acceptance Form in (a) and (b) above must be obtained by the candidate from the City Clerk prior to qualifying.

Candidates are required to file no later than <u>12:00 o'clock noon</u> on Wednesday, February 24, 2016.

#### Mission/Vision


