Dear Chief Colina:

The Civilian Investigative Panel ("CIP") considered the above case at its meeting on June 19, 2018. The Panel voted to not sustain allegations of improper procedure and biased based profiling.

Procedural history: Internal Affairs received this complaint on January 23, 2018. It was assigned to Sergeant Ivonne Valdes and closed as a Non-Complaint on January 26, 2018. The CIP received the file on February 15, 2018.

Complaint: Ms. Mastrapa said the police were called to a landlord/tenant dispute and Officer Yearby held her against her will, harassed her, and favored the tenants because they are black. She said Officer Yearby asked her personal questions regarding her health and private questions not related to the incident.

Policies considered: Departmental Order 15, Chapter 4, Section 4.4 states that biased based profiling shall not be used when sworn members of the MPD exercise police authority. Departmental Order 1, Chapter 11, Section 11.6.12.2 requires officer to prevent breaches of the peace and quell disturbances growing out of such matters. They shall advise concerned parties why police action may not be possible; and, if necessary, take persons breaking the peace into custody.

Investigation: Ms. Mastrapa was interviewed by the CIP and stated that the tenants in her rear apartment were served with an eviction notice. One of the tenants was verbally aggressive with her and the tenant called the police to complain that the lights in the apartment were not working. She said that there was an electrical issue and the tenant disputed her claim when Officer Yearby arrived, She believes that Officer Yearby failed to follow protocol because she should have listened to each person separately. She claimed that Officer Yearby put her in the patrol car and was left there without water for almost half an hour. She said Officer Yearby asked her questions about her daughter and whether she goes to a doctor. She doesn't believe this was proper.

The recordings of 911 calls and radio transmissions were reviewed. The first call was from the tenant asking for the police because the complainant keeps turning off the lights. The second call was from the complainant requesting another officer because she was being harassed by the female officer. She did not mention being in the police car. The third call is from the tenant asking for the police to respond again because the landlord was playing with the lights. The fourth call is from Ms. Mastrapa saying that the police do not need to respond and that she had explained to the officer that there was an electrical problem.

Since this matter was classified as a non-complaint, there was no statement from the officer.

CIP resolution of the complaint: The CIP voted to not sustain the allegations of improper procedure and biased based profiling. There were no witnesses to the incident and there was no evidence to support the allegation that Officer Yearby was biased.
