

Attached you will find the final amendments to the Mayoral Campaign for 2009. The first filing is an amendment to the 10/10/2009-10/29/2009 summary page which should have been labeled G309. The second is the final amendment to the TR which only changes the date of the last expenditure and therefore the end date of the report.

I have also included the final accounting by the Miami-Dade County Commission on Ethics & Public Trust which comports with the TR report. As you will see, the final figures includes \$13,030 in expenditures that the bank debited and then credited back because the signatures were questionable. The checks were written in October and placed as a debit that month and then as a credit the following month. Finally the account had \$6655.00 in bounced checks which were credited and the debited. All of these changes are reflected in the original amendments filed. The two adjustments explain the difference between the original bank statement tally and the report as a result of internal bank policies.
