## H. TODAY'S HEARINGS

H.1

Hearing of Appeal on behalf of Osmel Martinez, former Maintenance Mechanic Supervisor, concerning his 2-day suspension, effective January 26, 2009.

Prior to entering into Osmel Martinez' hearings, the Chairman advised that the meeting would adjourn at 1:00 p.m. today, which is the reason the Board would not hear the other two cases (Items H.4 - Daylet Diaz and H.5 - Jean Marie Jean-Felipe) scheduled for today. He went on to say that depending on how things go with Mr. Martinez' case today, the Board may have to set a special meeting to hear Ms. Diaz' case.

Following discussion, the Board continued with the consolidated cases of Osmel Martinez (Agenda Items H.1 through H.3) that began on January 25, 2011.

Janeen Richard, Assistant City Attorney, represented the Department.

Michael T. Pancier, Kevin Guanaga, Attorneys at Law, represented the Appellant.

The Board took up discussion on the department's resting of its case and ACA Richard advised the Board that she would not rest her case because of the various cases being heard at the same time. The Rule of Witnesses was invoked and all witnesses were

sworn in individually. Witnesses for the Appellant appeared in the following order:

1. Richard Brioso, (former) Assistant to the Director, General Services Administration. Questions were posed by Board Members Moy, Dames and Kaplan during the testimony of witness Richard Brioso.

Following direct and cross examination of Richard Brioso, ACA Richard stated that she did not have any other witnesses to call (with regards to the Whistleblower case) and asked if she should call Osmel Martinez to testify with regards to the cases involving his 2-day suspension and termination or should she wait until Mr. Martinez testified. Chairman de la O responded that since the cases were consolidated, she could call Mr. Martinez as a witness if she needed him to prove her case.

Witnesses for the City continued in the following order:

6. Osmel Martinez, Maintenance Mechanic Supervisor, City of Miami, Department of General Services Administration. (Osmel Martinez provided testimony via Certified Translator Fernando Bouza of Universal Language Services.)

Following Attorney Guanaga's cross examination of Osmel Martinez, Member Kaplan stated that if the Board cannot finish Osmel Martinez' cases this month (February) he would hope that the cases are scheduled to some time in the beginning of March 2011 because he will be on vacation for two weeks during the middle to the end of March.

Chairman de la O suggested that the Executive Secretary poll the Board for the purpose of coming up with a date to start Mr. Martinez' cases at 9:00 a.m. so that the Board can finish this case. The Executive Secretary asked if the Board was available to start the February 22, 2011 meeting at 9:00 a.m. Without objection from other Board Members, Chairman de la O responded in the affirmative.
