The Grievant was represented by Jonathan S. Minick, Attorney at Law. The Department of Human Resources was represented by Carlos Gamez, Assistant City Attorney, Office of the City Attorney.

The Rule of Witnesses was invoked and Chair Baños advised all witnesses to leave the chambers, and to not discuss their testimony with anyone. Opening statements were provided by both sides.

- 2. Eyran Kraus, Testing & Validation Supervisor, Department of Human Resources. Questions were posed to Witness Kraus by Members Ramlal, Harris, Riley and Sutton.
- Amy Klose, Director, Department of Human Resources. Questions were posed to Witness Klose by Chair Baños and Members Riley, Harris and Ramlal.
- 4. Jorge Gomez, Assistant Chief, Department of Police. Questions were posed to Witness Gomez by Member Sutton.
- 5. Ronald Papier, Major, Department of Police. Questions were posed to Witness Papier by Members Harris and Sutton.

The Grievant rested. No witnesses were called to testify on behalf of the Department. Both the Grievant and the Department provided closing arguments.

Prior to Board deliberation, Member Riley asked for a break to take a phone call. During the break, a settlement between the parties was reached. Upon reconvening, Assistant City Attorney Gamez announced that the parties had reached an amicable agreement, which was echoed by the Grievant.
