Copy of a Request from Osnat K. Rind, Attorney, Phillips, Richard, & Rind, P.A., on behalf of Sandy Dorsainvil, *former* Cultural Arts Center Manager (Unclassified), pursuant to Civil Service Rule 2.7 - Appearance Before the Board, concerning Ms. Dorsainvil's Termination, effective April 4, 2016. (DISCUSSION)

Osnat K. Rind, Attorney on behalf of Ms. Dorsainvil, appeared before the Board and stated that the request for an Appeal hearing was before the Board for discussion, because Ms. Dorsainvil's classification is in the Unclassified service. She went on to say that pursuant to a ruling in the matter of Jorge Martinez-Esteve v. City of Miami, all classifications that are not specifically listed in the City Charter, are to be considered as "Classified". Therefore, she continued, Ms. Dorsainvil should be considered Classified, and granted an Appeal hearing.

Assistant City Attorney Kevin Jones advised that the employee was indeed Unclassified; however, the department had no position on whether the Board should consider granting a hearing.

Following discussion, the Board entered a motion to grant the hearing as requested by Ms. Dorsainvil.

Special Counsel Carla Barrow opined that Rule 14 requires that employees requesting an appeal hearing be "permanent, classified" employees.

Chair Harris reminded Special Counsel that during Board discussion, where there is a motion on the floor, it was improper at that point for Board Counsel to interject, unless a Board member invited her into the discussion.

Following discussion, the Board considered the motion to GRANT the APPEAL hearing, which resulted as follows:

Motion by Chief Examiner Ramlal, seconded by Member Dames, that this matter be APPROVED. PASSED by the following vote.

Attorney Rind asked that Ms. Dorsainvil receive a letter detailing the reasons for her termination within 5 days, as required under Rule 14. ACA Jones responded that the department would comply with that request.
