G. REQUESTS FOR HEARINGS

G.1 Request for hearing on behalf of Lazaro Cabezas, Telecommunications Technician, from Osnat K. Rind, Attorney, Phillips, Richard, & Rind, P.A., pursuant to Civil Service Rule 16.1- Investigation by the Board or 16.2-Complaint by Employee. (DISCUSSION)

Osnat Rind, Attorney on behalf of Mr. Cabezas appeared before the Board and recited the hearing history (since 2010) regarding the discrepancy in pay grades, which led to the request before the Board today. Attorney Rind relayed that there are only 2 employees in this classification; one employee is paid at a Range 32M and the other employee, Mr. Cabezas, is paid at a Range 25M. She went on to say that although the Board heard this request in 2010 under Rule 14, she is asking, in an abundance of caution concerning exhausting her client's administrative remedies, that due to the continuation of this discrepancy, the Board now hear it under Rule 16.1 or 16.2, and provide a recommendation to the City Manager.

Chair Baños asked if the department wished to make any remarks. Stephanie Panoff, Assistant City Attorney, Office of the City Attorney, appeared before the Board and responded that initially, Mr. Cabezas and the other employee Rodrigo Jimenez filed Rule 14 hearings before the Board, appealing what they believed to be "de facto demotions". Following a classification audit, the salary range, or pay grade for the classification of Telecommunications Technician had been reduced from R32M to R25M, to be in line

with the duties and requirements of the classification. Mr. Jimenez entered into a Settlement Agreement, which re-instated the salary range for his new classification - "Telecommunications Technician - RJ". Mr. Cabezas' hearing before the Board moved forward, and the Board found that the City was entitled to set/revise salary ranges for classifications, but recommended that, to be fair, Mr. Cabezas' salary range should also be re-instated, which the city manager rejected.

Assistant City Attorney Panoff further opined that although the employees have different salary ranges and are performing in the same classification, there was no abuse of power in this case, since the City is only abiding by a settlement agreement. She concluded that if Mr. Cabezas was not content with the results of his 2010 hearing at the time, he should have appealed to Circuit Court, not come back six years later for another hearing before the Board.

Following discussion, the Board entered a motion to GRANT the request for a hearing, pursuant to Civil Service Rule 16.1 - Investigation by the Board, which resulted as follows:
