Chair Banos asked if there any objections to the Findings of Fact as presented. ACA Gamez appeared before the board and advised that he had spoken with Eugene Gibbons (attorney for Mr. Gurlacz) and agreed to the wording in all but two findings, #3 and #9.

Member Harris asked if #3 could be revised to include the word "estimated" before the word "speed". She went on to express her dissapointment in not seeing Attorney Gibbons present when this matter was being discussed.

Chair Banos stated that the word "deadlock" as found in finding #9 gave him pause; and that a more accurate reflection of the way the vote happened is because the board did not have all 5 members. ACA Gamez researched the definition of "deadlock" and opined that the board's vote was a deadlock, but understood if the Board wished to find alternate wording.

Chair Banos asked if the Executive Secretary could come up with language for this finding, to which she replied in the affirmative. She read the revised wording in Finding #9 as follows "...the vote resulted in a tie as to the issue."

Following discussion, the Board entered a motion to APPROVE the Findings of Fact as AMENDED, which resulted as follows:
