G. REQUESTS FOR HEARINGS

G.1

Copy of a Request for Hearing from Eugene G. Gibbons, Attorney, on behalf of Jonathan Yavneh, Police Lieutenant, pursuant to Civil Service Rule 16.2, concerning a violation of 11.2 Assignment to Other Work. (DISCUSSION)

Eugene G. Gibbons, Attorney on behalf of Jonathan Yavneh appeared before the Board and introduced himself, giving an overview of his work history. He went on to say that he expects to represent other Fraternal Order of Police members before the Civil Service Board.

Chairman Silverman advised that the Board had a copy of Attorney Gibbons' request and asked if Attorney Gibbons had anything to add. Attorney Gibbons responded that Lieutenant Yavneh is requesting this hearing because he is working out of classification; in that the work that Lieutenant Yavneh is performing as a Field Training Coordinator has historically been performed by a Police Captain.

Chairman Silverman asked for the department's opinion on the request. Assistant City Attorney Richard responded that she had no objection to the request for hearing.

Chairman Silverman asked if any Board Members had any questions. Member Harris asked for Mr. Gibbons to explain the basis for the hearing request. Attorney Gibbons responded that they believed that the Police Department had unfairly shifted the burden onto Lieutenant Yavneh, in violation of Rule 11.2. He went on to say that from at least 1996 through 2007, when Lieutenant Yavneh took over, the work was performed by a Police Captain, and therefore, he should be compensated as a Captain. He further stated that the Board has heard these types of cases before in relation to Police and they would therefore like for the Board to grant a hearing in this matter.

Member Harris asked if Attorney Gibbons would clarify under which Rule he was travelling. Attorney Gibbons responded that he was travelling under Rule 11.2. The Executive Secretary advised the Board that the request was made pursuant to Civil Service Rule 16.2, alleging a violation of Rule 11.2.

Following discussion, the Board entertained a motion to GRANT the request for hearing, which resulted as follows:

Hearing of Appeal on behalf of Marly Saldarriaga, former Public Service Aide, concerning her termination, effective July 10, 2012.

Ronald J. Cohen, Attorney on behalf of Pierre Chery, appeared before the Board and advised that Officer Chery had mandatory training today, and would not be able to attend the hearing.

Chairman Silverman asked if this case was one of those cited for speeding. Attorney Cohen responded in the affirmative, and stated that the parties may be able to resolve the matter.

Chairman Silverman asked ACA Richard if she had any objection to the request for a

continuance. ACA Richard responded in the negative. Chairman Silverman asked if the Board Members had any questions. Member Harris asked whether this was a "speeding case", to which the Chairman responded in the affirmative. Member Harris asked ACA Richard if the department was in agreement with the request for continuance, to which the Chairman responded in the affirmative.

Chairman Silverman asked ACA Richard if she had any objection to the request for a continuance. ACA Richard responded in the negative.

Following discussion, the Board entered a motion to GRANT the continuance requested in this matter, which resulted as follows:

NON-AGENDA ITEM: Scheduling of Cases

Member Harris stated that she had one item that she meant to bring up at the last meeting. She went on to say that on behalf of Member Moy with regards to the calendar and as a reminder to how cases are prioritized, she had a discussion with the Executive Secretary after the last meeting for clarification. She went on to say that she wanted to remind the Board of statements made at the beginning of their terms, regarding the importance of scheduling termination hearings. She went on to say that she wanted the Executive Secretary to make the Board aware of the discussion they had regarding termination cases being given priority. She went on to say that a lot of the termination cases involve civilians, and that police cases seem to clog the system.

Member Moy stated that he agreed with Member Harris, and went on to say that civilian cases should be given the same priority as police cases, and we need to give more priority to terminations.

Chairman Silverman asked if anyone else wished to say anything regarding this discussion. Member Harris stated that she appreciated the efforts of the staff and advised that she and the Executive Secretary went over the process in more detail. She went on to ask if the Executive Secretary could provide those details to the Board, so that they all knew the process used to ensure that those cases are being prioritized.

Special Counsel Everett asked if there was a particular case that Member Harris was asking about that had been missed or improperly scheduled. Member Harris responded in the negative, and added that she just wanted the Board to be aware of the conversation, and how we are being sure that the cases are being prioritized.

Anthony Hatten, President, AFSCME Local 1907 appeared before the Board and asked about the appeal hearing on behalf of Terrel Cheever. The Executive Secretary advised that Mr. Cheever's hearing was scheduled for the Board's next meeting on March 5, 2013.
