Chair Harris asked if anyone was present regarding Police Officer Luis F. Pla's Military Leave Extension request. The Executive Secretary advised that the Board previously approved Officer Pla's military leave, and this request is for an extension, which needs the Board's approval, and is supported by the included military orders. E. GENERAL ITEMS

E.1 Hearing of Appeal on behalf of Francisco Sallano, Police Officer, concerning his 10-hr forfeiture, effective December 6, 2012. (DISCUSSION)

Rescheduled pursuant to continuance policy; pending settlement since June 24, 2014.

Chair Harris asked for the status on the case of Francisco Sallano. Assistant City Attorney Diana Vizcaino appeared on behalf of the Department and stated that she is still waiting on an executed agreement from Officer Sallano. Attorney Eugene Gibbons (Atty. Gibbons) appeared before the Board on behalf of Officer Sallano and confirmed the agreement with the City. He went on to state that Mr. Sallano is in receipt of the settlement agreement and was supposed to deliver it to the City. Atty Gibbons stated that the matter will be resolved very soon and asked that the matter be placed on the Board's next agenda.

DISCUSSED : Without objection, Chair Harris instructed the Executive Secretary to place this matter on the next agenda.

Hearing of Appeal on behalf of Rhausser Charles, Police Officer, concerning his 40-hour suspension, effective November 7, 2013. (DISCUSSION) Rescheduled pursuant to continuance policy; pending settlement since July 22, 2014.

Chair Harris asked for the status of this matter. Eugene Gibbons, Attorney on behalf of Officer Rhausser appeared before the Board and advised that the settlement was discussed but an agreement was not reached. Assistant City Attorney Diana Vizcaino appeared before the Board and confirmed that the City's settlement offer was rejected by Officer Rhausser and asked that the case be placed back on the Board's calendar.

DISCUSSED: The Executive Secretary will place this matter on the Board's calendar.

Hearing of Appeal on behalf Jose Rilo, Parks Operations Coordinator, concerning his 3-day suspension, effective March 24, 2014. (DISCUSSION) Rescheduled pursuant to continuance policy; pending settlement since July 8, 2014.

Chair Harris asked for the status of the Jose Rilo matter. Assistant City Attorney Diana Vizcaino appeared before the Board and advised that a settlement agreement has been fully executed by both parties, and the document was received and filed by the Board's Secretary at today's meeting. Osnat Rind, Attorney on behalf of Mr. Rilo, confirmed the agreement.

SETTLED: Case will be closed and removed from the Board's docket.

Notice of a Withdrawal from Osnat K. Rind, Attorney, on behalf of Trinidad Varela, C.I.S. Desk Operator, concerning her 8-hour suspension, effective June 24, 2014. (NOTIFICATION)Hearing of Appeal is scheduled for today.

Chair Harris asked for the status on the case of Trinidad Varela. Attorney Osnat K. Rind (Atty. Rind) appeared on behalf of the Employee and stated that the matter had been settled. Assistant City Attorney Diana Vizcaino (ACA Vizcaino) appeared on behalf of the Department and stated that the appeal request has been withdrawn. Chair Harris asked Atty Rind to explain what was happening with this case. Atty. Rind responded that the matter had been discussed and settled between the parties; thus the notice of withdrawal of appeal is confirmed.

Copy of Findings of Fact concerning the Investigation hearing on behalf of Lewis Mahoney, Parks Manager II, pursuant to Civil Service Rule 16.1 - Investigation by the Board, relative to an alleged Abuse of Power by Department Directors Motley and Klose. (DISCUSSION)

Chair Harris asked if there were any objections to the Findings and Recommendations as prepared by Special Counsel. Assistant City Attorney Diana Vizcaino (ACA Vizcaino) stated that she did not have an opportunity to review the proposed Findings with her client until this morning. ACA Vizcaino also stated that she discussed some proposed revisions of the Findings with Attorney Osnat K. Rind (Atty. Rind) and that she would like to make the changes and forward the changes to Atty. Rind and any objections can be addressed before the Board at the next meeting. Member Banos stated that he was also unhappy with the way the Findings were drafted and felt that information was missing concerning the efforts at resolution taken by the HR department.

Chair Harris asked to hear from Attorney Rind. Atty. Rind responded that she generally wouldn't object to ACA Vizcaino's request however, the City Manager is waiting for the Findings to make his final decision on the matter. She stated that because school started yesterday, Mr. Mahoney was forced to take a leave from his Dade County School Board (DCSB) job and he is currently losing pay pending the final decision by the Manager. She stated that her preference would be to get the Findings resolved today because the longer it is delayed, the longer the employee will suffer the loss. ACA Vizcaino stated the decision by the Human Resources (HR) Director still stands at this time, and whether or not the City Manager accepts or rejects the Board's recommendation, the decision has been made which was a denial by the HR Director. She went on to state that the actions that Mr. Mahoney decided to take were his decision.

Chair Harris stated that the Findings need to be resolved today. Member Banos requested that the Chair grant a break to allow both parties to discuss the proposed Findings. Without objection, the Chair allowed 20 minutes for the attorneys to discuss the matter.

ACA Vizcaino stated that if the City Manager had a desire to [reverse the HR director's decision], that action would have been made and the previous denial would have been revised and the request approved. ACA Vizcaino went on to state that it is unlikely that it (Outside Employment Request) will be granted or approved. Atty. Rind stated that the President of the AFSCME Union had a meeting with the City Manager yesterday who represented that he was waiting on the Board's Findings. Member Banos reiterated that Chair Harris has granted 20 minutes to allow both parties to discuss the Findings.

Following a brief break, the Board reconvened to discuss the Findings in detail. Special Counsel Clyne identified the proposed modifications with both parties and the Board, and the Board had discussion regarding the recommendations.

Following discussion, the Board entered a motion to APPROVE the Findings as amended which resulted as follows:
