Member Harris stated that there are still several hearings pending, in particular the Cheever case and a few "speeders", and asked ACA Richard if she could provide an update as to when the Agreements would be forthcoming.

ACA Richard responded that with respect to the "speeders", there is a slight delay, as

cases were transferred from Attorney Ronald Cohen's office to Buschel and Gibbons, P.A. She went on to say that in the Cheever case, Attorney Braverman and she had been in conversation regarding possibly bringing the matter back to the Board.

Michael Braverman, attorney on behalf of Terrel Cheever, appeared before the Board and advised that he and ACA Richard had explored the matter and he did not believe there was going to be a resolution. He then went on to ask if the appeal could be placed back on the Board's docket for hearing.

Member Harris stated that the City stated in good faith that they were going to settle the case and it has been several months without resolution. ACA Richard responded that the delay is not due to the City. Member Harris stated that she did not want to place blame, however one of the things that upsets her is not having closure and swift justice, which is one of the things that the Board is supposed to be about. She went on to say that in this particular case, we're talking about someone who is in a critical position, and who has lost his job, and questioned if that is in the best interest of the City.

Chairman Silverman stated that the bottom line is to expedite this matter.

Attorney Braverman responded that he agreed with Member Harris wholeheartedly, but this case involved the employee undergoing medical assessments and reviews, which took a lot of time. He went on to say that no one has been intentionally delaying resolution of this case, and it is his understanding that Mr. Cheever is back at his job, however, his superiors have concerns regarding his fitness for duty. Therefore, the matter has to be re-set for hearing.
