

This memorandum is to follow-up recent discussions on the MRC Parking Regulations by the Department Directors. Based upon my discussions and recommendations to the City Manager the following parking regulations are to be implemented.

1. Use of a reserved parking space is at the discretion of the individual assigned the parking space.
2. Parking in non-reserved parking spaces in the garage will be on a *first come* basis, including 24 hours cars.
3. Employees with personal cars or city cars may park in lots 16 and 17, as may citizens visiting the building.
4. 8 hour cars are to be parked in the garage or in lot 17 overnight. 8 hour cars parked in the garage overnight are to park on the 5th floor or above.
5. Employees with City cars are not to use the metered parking spaces in front of MRC on 2nd Avenue during working hours.

Please revise the current parking regulations to reflect the above provisions with an e-mail follow-up to all employees.

Effective Monday, May 8, 2000, the Miami Riverside Center Parking Regulations will be revised as follows:

- 1. Parking in non-reserved parking spaces in the MRC garage will be on a *first come* basis, including 24-hour cars.**
- 2. Employees with personal cars or city cars may park in Lots 16 and 17 overnight, as may citizens visiting the building.**
- 3. All 8-hour cars are to be parked in the garage or in Lot 17 overnight. 8-hour cars parking in the garage overnight are to park on the 5th floor of the MRC garage or above.**
- 4. Employees with City cars are not to use the metered parking spaces on 2nd Avenue in front of the MRC buiding during working hours.**
- 5. Use of a reserved parking space is at the discretion of the individual assigned the reserved parking space (i.e., individual assigned parking space is on vacation and permits an individual to park in his or her parking space).**
