MEMORANDUM OF UNDERSTANDING

42 HOUR WORK WEEK

IAFF, LOCAL 587

This Memorandum of Understanding is entered into between the City of Miami and the International Association of Firefighters, Local 587 to clarify the intent of the parties, specifically Articles 23 and 24 of the 1995-1998 labor Agreement, as it applies to leave time accumulations, conversions, banks and payoffs for employees working on a 42 hour work week.

The parties hereby agree that leave time accumulations, conversions, banks and payoffs for employees working on a 42 hour work week will be prorated based upon a 48 hour work week.

The leave time accumulations, conversions, banks and payoffs for employees working on a 42 hour work week will be in accordance with the attached conversion charts.

42 HOUR CONVERSION AND HOUR ACCUMULATION

48 TO 42 HOUR FORMULA: 48 HOURS X 87.5% = 42 HOURS

42 TO 48 HOUR FORMULA:

42 HOURS X 1.143 AND ROUND TO LOWEST HOUR = 48 HOUR TIME

EXAMPLE: FF CONVERTS 1000 HOURS OF 48 HOUR TIME TO 875 HOURS OF 42 HOUR TIME. TO CONVERT BACK: $875 \times 1.143 = 1000.125$, ROUNDED TO LOWER HOUR = 1000 HOURS

42 HOUR I, EPL, AND E TIME ACCUMULATION:

I = 8.75 HOURS PER MONTH E = 8.75 HOURS PER HOLIDAY EPL = 17.5 HOURS ANNUALLY

I TIME ANNUAL PAY OFF:

AFTER 525 HOURS MAY OPT FOR PAY FOR ALL HOURS IN EXCESS OF 52.5 HOURS ANNUALLY...

OR MAY OPT TO CREDIT TO VACATION LEAVE AT RATE OF 4.375 FOR EACH 8.75 HOURS EARNED.

IF AND K TIME:

42 HOURS PER YEAR.

42 HOUR CAPS FOR I TIME:

1050 HOURS AND 50% FOR EACH ADDITIONAL HOUR.

PREMIUM PAY:

ONE-HALF ACTUAL TIME WORKED ON THE HOLIDAY.

HOLIDAYS:

8.75 HOURS FOR EACH HOLIDAY WHETHER WORKED OR NOT.

VACATION:

BASE PER YEAR = 105 HOURS LONGEVITY VACATION (YEARS 6,7,8,9,10) = 8.75 HOURS PER YEAR LONGEVITY VACATION (YEARS 11 AND UP) = 4.375 HOURS PER YEAR VACATION CARRYOVER = 150 HOURS

CALL BACK PAY:

REMAINS 4 HOUR MINIMUM.
