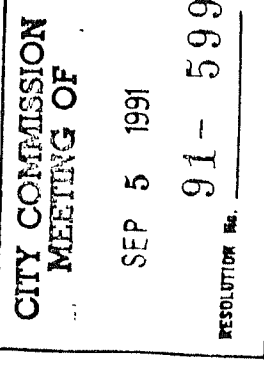
A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A MEMORANDUM OF UNDERSTANDING, IN A FORM ACCEPTABLE TO THE CITY ATTORNEY, MODIFYING THE EXISTING COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF MIAMI AND THE INTERNATIONAL ASSOCIATION OF FIREFIGHTERS, LOCAL 587, IN EFFECT FOR THE PERIOD OF OCTOBER 1, 1990 THROUGH SEPTEMBER 30, 1993, ADOPTED PURSUANT TO RESOLUTION NO. 91-346, ON MAY 9, 1991, BY THE CITY COMMISSION; SAID MODIFICATION TO PROVIDE FOR A ZERO PERCENT (0%) ACROSS-THE-BOARD INCREASE IN WAGES FOR FISCAL YEAR 1991-1992 AND A FOUR PERCENT (4%) ACROSS-THE-BOARD INCREASE FOR FISCAL YEAR 1992-1993; AND FURTHER TO MODIFY THE REOPENER CLAUSE AS SPECIFIED IN THE 1990-1993 LABOR AGREEMENT, ARTICLE 41 - TERMINATION AND MODIFICATION WITH THE EXCEPTION OF ACROSS-THE-BOARD INCREASES.

WHEREAS, the City of Miami and the International Association of Firefighters, Local 587, the collective bargaining agent for members in Local 587 have entered in negotiation modifying across-the-board increases on wages; and

WHEREAS, the International Association of Firefighters, Local 587, has agreed to forego a four percent (4%) increase for Fiscal Year 1991-1992 and has agreed to a zero percent (0%) across-the-board increase for Fiscal Year 1991-1992 and a four percent (4%) across-the-board increase for Fiscal Year 1992-1993; and

WHEREAS, the International Association of Firefighters, Local 587, has further agreed to modify the reopener clause in the 1990-1993 collective bargaining agreement as specified in the 1990-1993 labor agreement, Article 41 - Termination and Modification with the exception that negotiations shall not include wage increases;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:



Section 1. The recitals and findings set forth in the Preamble to this Resolution are hereby adopted by reference thereto and incorporated herein as if fully set forth in this Section.

Section 2. The City Manager is hereby authorized to enter into a Memorandum of Understanding, in a form acceptable to the City Attorney, between the City of Miami and the employee organization known as the International Association of Firefighters, Local 587, for the period of October 1, 1991 through September 30, 1993, to provide for a zero percent (0%) increase for Fiscal Year 1991-1992 and a four percent (4%) across-the-board increase for Fiscal Year 1992-1993 and to reopen negotiations as set forth in Article 41 - Termination and Modification with the exception of wage increases.

Section 3. This Resolution shall become effective immediately upon its adoption.

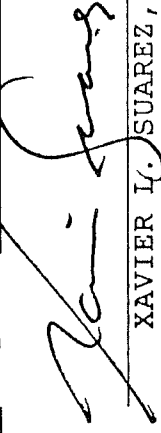
